On- line registration

It has been open an available on-line registration system through this page to participants, under the **event registration** section. Please complete the information required on the form, and choose a payment method. For wire transfer, automatically appear as pre-registered, to validate your registration you must not forget to send an e-mail to the Technical Secretariat with the copy of the transfer voucher.

For Visa card, you can pay the amount through a payment gateway secure environment with the bank. In both cases, registration will be confirmed by sending an email to the address specified in the registration process.

Confirmation of Enrolment Policy

Upon completion of the registration process, the system sends a custom mail where he confirms Event Registration and provides a Registration Number, please print it out and save it for future reference.
